The regular meeting of the Pocomoke City Mayor and Council was held in the Council Chambers at City Hall on Monday, January 22, 2018. The meeting was called to order at 6:30 P.M.

Review Minutes:

In a motion (Hirshman, Downing passed) to approve the minutes of the January 8, 2018 meeting.

Review and approval of bills:

In a motion (Tasker, Trotterpassed) the bills presented to be paid. (Copy of bill list attached to original minutes).

Atlantic General Hospital Care Giver Annual Update-Michael Franklin to present-Action Needed:

Mr. Michael Franklin, CEO of Atlantic General Hospital. Mr. Franklin gave an update on the hospital. He talked about the County Health rankings for Maryland, Worcester County ranks 15 in the state based on weighted scores for health behaviors, clinical care, social and economic factors and the physical environment. Worcester County ranked 10 based on an equal weighting of length and quality of life. He talked about how they could affect healthy choices behavioral throughout the County evenly. He talked about how the community could better educate the public on health factors, and how we need to make sure the people know about good health insurance. He stated that our County was becoming older with most of the growth above the age of 65. We need people under the age of 65 to take care of the 65 and older people. He stated that there is work to do as to how we provide the right amount of service and deal with some of the health issues in the coming years. He stated that Worcester County is designated as both a health Professional Shortage Area and a Medically Underserved Area/Population. This could mean limited access to health care, longer wait times for patients, or overuse of emergency system care. Worcester County is very under-served in Behavioral Health, we have about 70% less access to behavioral health professionals than the rest of the state. He stated that we need to figure out how to get more and better behavioral health professionals in Worcester County, as it relates a lot to opioid deaths and alcohol use. He spoke about priority areas for Worcester County and how better to serve the County. Cancer was the number twopriorty for our area with respiratory disease and smoking following. The health care providers need to find better a way

of addressing these issues. Atlantic General's strategic vision has gone from building a hospital to trying to bring all the services together and coordinate all the different health care providers in our community in a way that is meeting the growing needs of our community. Atlantic General's goals and strategic planning is to provide the five rights for our community; Right Care, Right People, Right Place, Right Partners and Right Hospital. How to take those principals and develop goals around improving the health of population, enhancing the experience when receiving health care, and how to reduce the cost of health care in our community. Also, how can we create a better environment as to where we can locate and come to our community, and serve the people in our community. Atlantic General Hospital has a "Capital Campaign for the Future" to raise 10 million dollars in three years to help offset investments of 35 million dollars in five areas to update and address the needs of our community. They are a little less than half-way though the campaign and have raised 2.5 million dollars of that 10-million-dollar goal. Some of the things they have accomplished in opening the John H. "Jack" Burbage Regional Cancer Care Center; Comprehensive Women's Health Center; and Modernization of their Patient Care Areas. They have expanded to provide better technology through-out the region. He stated he hopes to continue to come back to share with how they are trying to work together and provide services to our community.

Acting Mayor Troast thanked Mr. Franklin for giving us the update on Worcester County health care needs.

ORDINANCE NO. 437

AN ORDINANCE OF THE MAYOR AND COUNCIL OF POCOMOKE CITY ORDAINING AND ADDING “CHAPTER 147 – Vacant and Blighted Building Ordinance” TO THE POCOMOKE CITY CODE INTRODUCED BY: Acting Mayor Esther Troast on behalf of the City Council:

AN ACT to add Chapter 147- Vacant and Blighted Building to the Pocomoke City Code.

A. The purpose of this chapter is to establish a mechanism to protect residential and commercial neighborhoods from becoming blighted through lack of adequate maintenance and to ensure the security of vacant properties.

B. The provisions of this chapter are in addition to and not in lieu of any other applicable provision of the Pocomoke City, Code of Ordinances.

In a motion (Trotter, Hirshman passed) to adopt Ordinance No. 437.
