Council Comments

Councilmember Troast thanked Public Works Department for quick action on installing grates on the large open-ended pipes in a citizen's back yard on Cedar Run.

Councilmember Nock said he has heard rumors that he is supporting certain candidates for the mayoral and District 3 seats. He would like to set the record straight that that is not true. He is not supporting or endorsing anyone.

Department Comments

Bill East, Public Works Director, he had a meeting with the County to coordinate painting of the crosswalks at the school. He will meet with the County Commissioners.

Karah Burton-Lacey, Downtown Events Coordinator, had a meeting with downtown Pocomoke Association meeting on Wednesday. The DPA has an opportunity to have benches donated. They are of very good quality and are resistant to chipping, warping, fading, cracking, splintering, etc and do not need to be painted or varnished. They should be installed before the springtime events.

Chief M. Lee Brumley, last week when the County and State were in the City doing some interdiction work, they made a total of 20 stops. Drugs were recovered during a few stops. The Police Department will be having an open house on Wednesday, February 5th from 5:00 to 7:00PM. He would like to see everyone stop by.

Jeff Gleason, Human Resources Director, the train station has been cleared out and the City will be in the process of painting. The project should be finished by the end of February. Councilmember Holland asked that he make an announcement regarding the City Manager. Mr. Gleason stated that as of January 30, 2020 the City Manager has resigned and is no longer working for the City.
