Comments from Audience

Caryn Abbott, Worcester County Commissioner, said since being sworn in, she has learned so much more about how local government works and has more to learn. As an elected representative of District 1, her campaign platform consisted of three main goals in mind. Bring revitalization to the area through economic development, keeping kids off the street and attract good paying jobs to the area. So far, she has been successful with a program at the Middle School and she started the Future Warriors program with the parks & Recreation that has one full-time dedicated individual. She would like to develop the industrial park to bring the jobs related to Wallops growth. To bring economic development to Pocomoke, she needs the help of citizens. The elected Mayor & Council has to let her work for the people. How do we move Pocomoke forward? Are we open for business and business friendly? Most people don't understand the hours that must be put in to truly revitalize an area. We all have to be available to hear from developers when they want a meeting and show interest in our area. Comments from Chief of Police

Chief Hancock wanted to congratulate two officers Cpl. Anthony Rhode and Ptlm. Tyler White for seizing almost 2 pounds of marijuana on a traffic stop. He wanted to give a shout out to Mike Shannon and Jaime Evans on their Dockjam event. Everything went well. Officers and K9s from other departments also assisted. The only thing that needs to be worked on is traffic control at the crosswalks after the event lets out. A new phone system has been put in at the police station to replace an old, outdated system. If someone calls are missed, they are transferred to the next person in line and also sent to emails. He will have officers attending a stress management course and other officers attended an effective communications class. The website has been updated to show Accountability Board complaints. He modeled the format after the Wicomico Sherriff's website. He had a meeting with Red Speed to see about moving one of the cameras. A study needs to be done. Child safety seats will be given out and there will be a trained officer at the PD available to install seats or to inspect them. Officers will do a meet and greet at Greenwood Elementary School. Ptlm. Fitchett has organized a basketball tournament and gave a presentation on how it works. The goal is to give a scholarship to a senior.
