Dan Brandewie, Planning Director reminded everyone that they will hold a Public Hearing on September 27, 2023 for a zoning map amendment and will also have a discussion on the Cannabis Moratorium.

Dawn Bloxom said she asked all the Councilmember's at the last meeting what their vision for the city is. She wants to know if Councilmember Downing also has a vision. Councilmember Downing said she would like to see better housing in certain sections of town. She would also like to see people coming together to accomplish things. She would like to see the whole city beautified. Ms. Bloxom said are there any plans to hold landlords accountable for their properties. Councilmember Downing said both she and Councilmember Troast said they have been working with Planning and Zoning and Code Enforcement on drawing up Codes for rentals. The city is 60% rentals and need to be held accountable for the properties and make sure things are up to code. She asked Councilmember Marsh about the mentioning of Wawa coming into town. Ms. Bloxom said it sounded like she was taking credit for Wawa coming to town but the property owner didn't know her name. Mayor Nock said Councilmember Marsh did not take credit for Wawa coming to town but that she contacted Wawa Corporate and talked to them about how to get the business in the area. She was given names and some information about the process which she passed on to others.

Nola Tullar said her concern is that things have escalated into another phase of violations. She now sees homes that have things like garbage and furniture that might be creating a fire hazard. She feels that it needs to be addressed. Councilmember Troast said if someone sees something or a certain property, they can call Code Enforcement and he has the authority to involve others as the situation calls for. Ms. Tullar said there is a certain property on Cedar St that has opossums and snakes. She worries about kids walking by and getting bitten by a rabid animal. Mayor Nock said she can start with the County Health Department. She also asked about the LED street lights. Councilmember Troast said DP&L was replacing 17 per year. She is not sure if they have done that for this year yet. There

are also some street lights out. When they begin to flicker, it's time to change it. There is one out on Cedar St. You cannot see at night, it's very dark in that area and difficult to see when it's raining. She also asked if we are still looking for a city manager. Mayor Nock said yes, there are a few interviews scheduled. She also asked about barking dogs. Excessive barking needs to be addressed. Mayor Nock said that might need to be reviewed in out Charter but for now, that is Animal Control. She asked if the Chief still puts crime reports on their webpage. Chief Hancock said he no longer does that because of legal issues that could arise.
