<u>First Reading of Resolution 2026-R-07; Resolution Supporting Participation in the Sustainable</u> Maryland Certified Municipal Certification Program

Mayor Nock reads Resolution 2026-R-07 After the reading, the council reviewed Resolution 2026-R-07 supporting participation in the Sustainable Maryland Certified Municipal Certification Program. No action was taken. The resolution will be considered for second reading and vote at the next meeting.

Room Tax increase for Worcester County

Mayor Nock reviewed Worcester County's room tax proposal and presented it to the Council asking for their support of the increase. He informed them that Ocean City has voted unanimously to support it and to send a letter. This helps Pocomoke because visitors pay, not the residents. The county's room taxifies to short term stays in hotels, motels, condos and similar accommodations. It's charged to guests, not our presidents and is currently at 5%. Moving it to 6%. A 1% increase would yield 35 to \$40,000 for the city per year. Motion to approve made by Councilman Marshall, seconded by Councilwoman Cottman. Motion passes.
